BEFORE YOU BEGIN

Establish your in-coming President, Treasurer, and any other Tier-Required Executive Board Officers. Prepare the following items **in collaboration with** your executive board officers:

- Review the handout "[2019-2020 RSO Tiered Model](#)" and select your preferred tier (Tier 1 or Tier 2)*
- Draft your organization mission (**2-4 sentences MAX**).
- Select your Organization profile image and save it as an image (JPEG, JPG or PNG) -Files over 25 MB will not be accepted
- Gather the names, roles, G numbers, and email addresses of your executive board officers
 - Tier 1: 2 Officers
 - Tier 2: 4 Officers **
- Gather a copy of your constitution (Word doc or PDF)
- Complete the [GPA Authorization Form](#) (link: <https://si.gmu.edu/wp-content/uploads/2019/03/GPA-Authorization-Form.pdf>)
The Tier-Required Officers must physically sign the GPA Authorization Form. The form must be uploaded into the Application. The RSO will not be Re-Registered unless this is completed.

Complete Phase 1

 - Confirmation emails will be sent to you from forms@gmu.edu (do not reply to this email address)
 - For further information, the [RSO website's Re-Registration Phases](#) will be updated throughout the process.

Phase 2

- The Application is reviewed
- GPAs will be checked for all Tier-Required Officers (allow 2-3 weeks)
- Once approved - You are a 2019-2020 Registered Student Organization!
- Make decisions on whether your group will move forward to Phase 3: completing the Online Blackboard Trainings and Quizzes to have access to Funds or space reservations
